You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

TYPE

This product is issued as global certificate under English Law. It has no capital protection against market risk.

TERM

The product does not have a fixed term. It may be exercised by the investor or terminated by the Issuer.

OBJECTIVES

Objective of the product is to provide you with a specified entitlement according to predefined conditions.

You may exercise the product upon delivery of a prior written notice on predefined dates (Exercise Date) considering the Exercise Notice Period, with effect on the relevant Valuation Date.

Furthermore, the Issuer has the right to early terminate the product on a date designated at its discretion (the Ordinary Termination Date) subject to prior notification with effect on the relevant Valuation Date. After exercise or termination, you will receive a Redemption Amount in the Currency of the Product on the relevant Redemption Date. The relevant Valuation Date is the Exercise Date or the Ordinary Termination Date.

The Redemption Amount equals the Reference Price, taking into account the Multiplier, converted into the Currency of the Product minus the Management Fee.

You are not entitled to any right or entitlement resulting from the components of the Underlying (e.g. dividends, voting rights).



RISK INDICATOR





The risk indicator assumes you keep the product for the recommended holding period. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 5 years

The average investor holds this kind of product for about 5 years on average. Furthermore, we have chosen this period to enhance comparability with other investment products without a fixed lifetime.

In addition to selling the product through the exchange where the product is listed or off-exchange you may ask the Issuer for early redemption of the product by exercising your Warrant Right upon delivery of a prior written notice on predefined days. Please note that you may be required to hold a minimum number of products greater than one for effective exercise. You must instruct your depository bank, which is responsible for the order of the transfer of the specified products. Upon effective exercise you will receive a Redemption Amount as described in more detail under "What is this product?" above

Under normal market conditions, you may sell this product in the secondary market. The price depends on the markets parameters prevailing at the time, which could put the invested amount at risk.

Please be aware that exchange trading of the product may cease prior to the Valuation Date.
