You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

TYPE

The product is issued as uncertificated security under Swiss Law. Apart from the form and establishment of the product, all rights and obligations arising from it shall be determined in all respects in accordance with French law. It has no capital protection against market risk.

TERM

The product does not have a fixed term. It may be exercised by the investor or terminated by the Issuer.

OBJECTIVES

Objective of the product is to provide you with a specified return, if any, according to predefined conditions. You will participate in a daily leveraged manner in any price trend of the Underlying. The value of the product (Cash Value Short) is calculated from a Leverage Component and a Financing Component. The daily leverage effect amplifies the effect of rising and falling values of the Underlying on the Cash Value Short.

You can request a repayment from the Issuer of the products by exercising your exercise right by submitting a previous, written declaration on predefined dates (each an Exercise Date). Furthermore, the Issuer has the right to terminate the product with prior notice, on a date determined at its discretion (Ordinary Termination Date).

After exercising your exercise right or termination by the Issuer you will receive a Redemption Amount on the relevant Settlement Date. The Redemption Amount equals the Cash Value Short on the Valuation Date converted in the Currency of the Product. The Valuation Date is the day on which the exercise or termination becomes effective.

The Cash Value Short equals the Leverage Factor multiplied by the opposite Performance of the Underlying over one day (which may be positive or negative) (Leverage Component) adjusted by the Financing Component.

The Financing Component (which may be negative or positive) represents the costs or gains for borrowing or lending money to create leverage (Reference Rate taking into consideration an Interest Margin), the costs of hedging the product (Hedging Cost) and a fee which covers the costs for structuring, market making and settlement and also includes a margin (Administration Fee). The Financing Component in general negatively impacts the Cash Value Short.

One feature of the product is the Reset Threshold. It is determined on the basis of the Reset Threshold in Percent in relation to the price of the Underlying. Should the Observation Price of the Underlying be equal to or above the Reset Threshold during the trading hours of the Underlying, a Reset Event will be deemed to have occurred. In this case, to determine the Performance of the Underlying, and consequently for the calculation of the Cash Value Short, a Reset Price will be used. The Reset Threshold is recalculated on this basis. This mechanism was designed to avoid that the value of the product becomes (almost) equal to zero. However, it does not prevent a loss close to a total loss of the purchase price from occurring.

As the value of the product is calculated recursively based on the leveraged daily Performance of the Underlying over one day, the performance of the product can be affected by a compounding effect for a period longer than one day. The performance of the product may differ significantly from the Leverage Factor multiplied by the overall Performance of the Underlying over that same period. In particular, daily up-and-down fluctuations of the Underlying can lead within a few days to completely different price movements between the Underlying and the product over a particular period of time. This means that if the Underlying is subject to fluctuations over a longer time period, this can have a negative impact on the price of the product, even if the Underlying has not changed significantly during the same time period. Due to this reason, this product is not suitable as a long-term investment.

Due to the daily leverage effect in the product, an increase of the price of the Underlying can significantly decrease the price of the product. Albeit, all subsequent falls in the price of the Underlying will lead to gains in the value of the product. However, the starting level for a recovery in the value of the product would then be very low, meaning that significant falls in the Underlying price would have only a minor effect on the recovery of the product.

RISK INDICATOR



Lower risk

The risk indicator assumes you keep the product for the sample period. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

Higher risk

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

WHAT HAPPENS IF BNP PARIBAS S.A. IS UNABLE TO PAY OUT?

Should the Issuer default or file for bankruptcy, you have the right to seek payment from the Guarantor pursuant to an unconditional and irrevocable guarantee of any amount due. Should the Guarantor also default, file for bankruptcy or in case of bail-in, you may suffer a loss up to the total amount

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 calendar day (sample period)

The recommended holding period indicated above corresponds to the sample period which was used to calculate the performance scenarios and costs of the product. Due to its leverage effect the product reacts to the smallest price movements of the Underlying, leading to profits or losses within unpredictable timeframes. Considering their functionality, this product is not suitable as a long term investment. For investors seeking a return, the risk related to the product increases considerably if they hold the product for longer than the sample period. For investors purchasing the product for hedging purposes the holding period depends on the hedging horizon of the individual investor.

In addition to selling the product off-exchange you may ask the Issuer for early redemption of the product by exercising your Warrant Right upon delivery of a prior written notice on predefined days. Please note that you may be required to hold a minimum number of products greater than one for effective exercise. You must instruct your depository bank, which is responsible for the order of the transfer of the specified products. Upon effective exercise you will receive a Redemption Amount as described in more detail under "What is this product?" above.

Under normal market conditions, you may sell this product in the secondary market. The price depends on the markets parameters prevailing at the time, which could put the invested amount at risk.

Please be aware that trading of the product may cease prior to the Valuation Date.

In unusual market situations, or in the event of technical faults/disruptions, a purchase and/or sale of the product can be temporarily hindered, or may not be possible at all.
