You are about to purchase a product that is not simple and may be difficult to understand.

## WHAT IS THIS PRODUCT?

### ► TYPE

The product is issued as uncertificated security under Swiss Law. Apart from the form and establishment of the product, all rights and obligations arising from it shall be determined in all respects in accordance with French law. It has no capital protection against market risk.

### ► TERM

The product has a fixed lifetime and will be due on the Redemption Date.

### ► OBJECTIVES

Objective of the product is to provide you with a specified return, if any, according to predefined conditions. You will participate in a leveraged manner in any price trend of the Underlying.

The product can expire early during its lifetime if a Knock-Out Event occurs. A Knock-Out Event occurs if the Price of the Underlying is at or below the Knock-out Level at any time during the Observation Period. In this case the product becomes worthless immediately.

Unless a Knock-Out Event has occurred, you will receive a Redemption Amount on the Settlement Date which equals the amount by which the Reference Price exceeds the Strike Price, divided by the Ratio, converted into the Currency of the Product.

You are not entitled to any right or entitlement resulting from the components of the Underlying (e.g. dividends, voting rights).

### RISK INDICATOR

## WHAT HAPPENS IF BNP PARIBAS S.A. IS UNABLE TO PAY OUT?

## HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 calendar day (sample period)

The recommended holding period indicated above corresponds to the sample period which was used to calculate the performance scenarios and costs of the product. Due to its leverage effect the product reacts to the smallest price movements of the Underlying, leading to profits or losses within unpredictable timeframes. For investors seeking a return, the risk related to the product increases considerably if they hold the product for longer than the sample period. For investors purchasing the product for hedging purposes the holding period depends on the hedging horizon of the individual investor.

There are no possibilities to take your money out early other than to sell the product off-exchange.
