You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

TYPE

The product is issued as uncertificated security under Swiss Law. Apart from the form and establishment of the product, all rights and obligations arising from it shall be determined in all respects in accordance with French law. It has no capital protection against market risk.

TERM

The product has a fixed lifetime and will be due on the Settlement Date.

OBJECTIVES

Objective of the product is to provide you with a specified return, if any, according to predefined conditions. You will participate in a leveraged manner in any price trend of the Underlying.

If the Reference Price exceeds the Strike, you will receive a Settlement Amount on the Settlement Date which equals the amount by which the Reference Price exceeds the Strike, divided by the Ratio, converted into the Currency of the Product.

If the Reference Price is at or below the Strike, there will be no payment and the product expires worthless.

You are not entitled to any right or entitlement resulting from the components of the Underlying (e.g. dividends, voting rights).

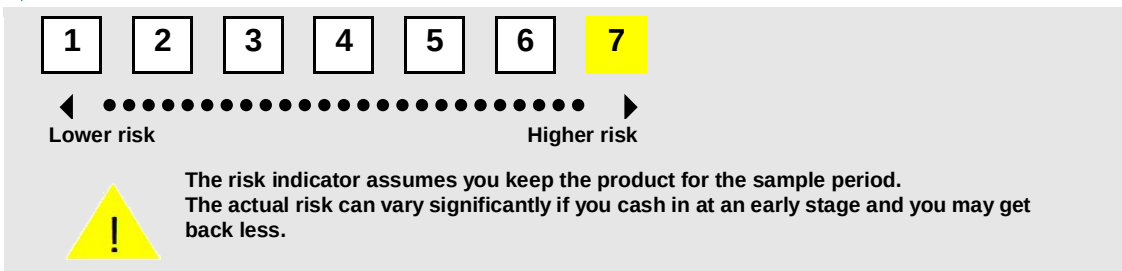

► RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

WHAT HAPPENS IF BNP PARIBAS S.A. IS UNABLE TO PAY OUT?

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 calendar day (sample period)

The recommended holding period indicated above corresponds to the sample period which was used to calculate the performance scenarios and costs of the product. Due to its leverage effect the product reacts to the smallest price movements of the Underlying, leading to profits or losses within unpredictable timeframes. For investors seeking a return, the risk related to the product increases considerably if they hold the product for longer than the sample period.
