You are about to purchase a product that is not simple and may be difficult to understand.

WHAT IS THIS PRODUCT?

► TYPE

The product is issued as uncertificated security under Swiss Law. Apart from the form and establishment of the product, all rights and obligations arising from it shall be determined in all respects in accordance with French law. It has no capital protection against market risk.

► TERM

The product has a fixed lifetime and will be due on the Settlement Date.

► OBJECTIVES

Objective of the product is to provide you with a specified return, if any, according to predefined conditions. You will participate in a leveraged manner in any price trend of the Underlying.

If the Reference Price is below the Strike, you will receive a Settlement Amount on the Settlement Date which equals the amount by which the Reference Price is below the Strike, divided by the Ratio, converted into the Currency of the Product.

If the Reference Price is at or above the Strike, there will be no payment and the product expires worthless.

You are not entitled to any right or entitlement resulting from the Underlying (e.g. dividends, voting rights).

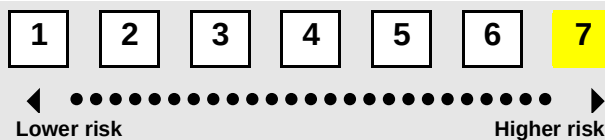

RISK INDICATOR



The risk indicator assumes you keep the product for the sample period.
The actual risk can vary significantly if you cash in at an early stage and you may get back less.

HOW LONG SHOULD I HOLD IT AND CAN I TAKE MONEY OUT EARLY?

Recommended holding period: 1 calendar day (sample period)

The recommended holding period indicated above corresponds to the sample period which was used to calculate the performance scenarios and costs of the product. Due to its leverage effect the product reacts to the smallest price movements of the Underlying, leading to profits or losses within unpredictable timeframes. For investors seeking a return, the risk related to the product increases considerably if they hold the product for longer than the sample period.
